#### February 7, 2022

After Chairman Miller gave the invitation for comment from citizens and other elected officials, the County Administrator called the roll and commissioners present were: Keith Davis, Jeff Burrough, Jim Borden and Steven Aderholt.

Commissioner Aderholt gave the invocation and County Administrator Robbie Dickerson led the Pledge of Allegiance.

## **CONSENT AGENDA:**

Motion was made by Commissioner Burrough and seconded by Commissioner Davis to add Classification of the Investigations Assistant to the Agenda as item 1(a), to approve the Agenda as amended, to approve the Minutes of the January 18, 2022 & January 26, 2022 meetings and to approve the Claims Against the County for January, 2022.

## **REPORTS FROM STAFF:**

County Administrator Robbie Dickerson stated that they will be talking to employees about payroll direct deposit. She stated, "It will be a benefit to our employees and it will also be a benefit to the Commission on the cost of doing checks and so forth. It has finally become economical enough to switch and it pay for itself just in labor, not counting the cost of checks, toner and envelopes."

Upon inquiry by Commissioner Davis, Robbie stated that there is no timeframe on the transition at this point, but that the bank is just waiting on them to get started.

Chairman Miller stated, "This will be a benefit for the employees of the county."

County Engineer Mike Short stated, "I want the Commissioners to know that I'm in the process of meeting with paving contractors to get you estimates. Hopefully, that will take place here in the next week or so. And we're just trying to get set up and get going as quickly as possible when the weather turns. If you have any requests, you can text them to me or call me, whatever, and I will get those reviewed and something back to you for your decision."
