At a scheduled meeting of the Walker County Commission held in their offices in the Walker County Courthouse Annex, Jasper, Alabama, at 9:30 a.m. on the 20th day of February 2024, Chairman Miller gave the welcome and called the meeting to order.

After Chairman Miller gave the invitation for comment from citizens and other elected officials, Barbara Higgins called the roll and Commissioners present were Keith Davis, Jeff Burrough and Jim Borden.

Commissioner Borden gave the invocation and County Attorney Richard Fikes led the pledge of allegiance.

DISCUSSION ITEMS BY COMMISSIONERS:

Commissioner Davis stated, "Thank everybody for their attendance and it's good to see everybody this morning. I thank our Sheriff Deputies for everything they do to keep us safe. They have had a busy couple of weeks reading about the drug busts and things that y'all have going on and things that y'all do. We really, really appreciate that. I appreciate Bill and his department and DA's Office and the things that they're doing also. Remember to pray for us that we continue to make decisions the best we can. We covet your prayers, we need your prayers."

Commissioner Burrough stated, "I, too, would like to thank everybody for being here. I appreciate each employee we have in the county and all the work that you do for us. I hope that as spring weather starts coming along we can get a lot of things accomplished in every department and try to make Walker County accessible and a good county to work for. And we've got several road projects ongoing. Of course, we're getting close to the spraying season as far as killing certain weeds and stuff on the sides of the roads, just be aware when you're out and driving, I ask the public to be aware of our workers. They work hard and like I say it's a tough job out there when you've got traffic going real, real fast. Keep up prayers for us and just hope that we continue to do what's best for Walker County."

Commissioner Borden thanked everyone for being here.

Commissioner Burrough stated, "I would add one more thing, like Mike talked about, people need to sort of get out and visit these access points. I mean, they're really a big benefit to people who likes to do that, kayaking, canoeing and stuff like that. It's really impressive. I think I've been to the 69 more than any of them, but I thank those people that did all the efforts to doing that. That is a real plus to this county. And I appreciate y'all doing that."

Commissioner Borden stated, "Can I add something. Along those lines, it just now occurred to me, a lot of the grants that are coming out from the Greater Birmingham, a lot of our towns are applying for the grants through these and it entails with outdoor activities, walking trails, our canoe launches, again, a lot of the towns, I've been to some of the meetings, Nauvoo, Cordova, possible Carbon Hill, I think, is in that where they do their five year plans for development to improve the communities in these areas. As Commissioner Burrough stated, they're out there and the citizens really need to take part in this. On the Saturday, these are some nice places to go, you know, go enjoy the outdoors and some fresh air."

Chairman Miller stated, "I, too, would like to thank everyone for coming to our meeting and it is with great respect we understand each and every one of you puts in a lot of work for the county, those that are employed we appreciate your service. We appreciate you citizens for showing up and being concerned. We appreciate just in general how this county is beginning to move forward and enjoy some better financial stability and changes. We certainly stand behind our Sheriff's Department. And with that I pulled some numbers just to kind of give us a little bit of perspective on how this Commission totally stands behind their Sheriff Department. Since I came into office in November of 2020 through February 16th, our Sheriff's Department and Jail, our Fund 107 total law enforcement expenditures through February 16th, \$25,216,725.46. I think that tells you that this Commission is behind their Sheriff's Department. This Commission is behind all employees of this county. We appreciate each, and every one. It is our job to be behind these folks and run this county in such a way that it moves forward every day. Thank each, and every one of you for that. I would ask for a motion to adjourn."
