Every person, firm, company, corporation or association, receiver or trustee, but not a governmental subdivision, engaged in any business, vocation, occupation, calling, or profession herein enumerated or who shall exercise any privilege hereinafter described for which a license or privilege tax is required shall first procure a state license, and a county license when so required, and shall pay for the same or shall pay for the exercise of such privilege the amounts hereinafter provided, and comply with all other provisions of this title. Alabama Code Section 40-12-40

Dear Sir or Madam:

The Walker County Commission, by resolution and order, has levied, in addition to all other taxes, licenses, or fees, a license and excise fee for the various trades, businesses, vocations, occupations and professions engaged in or carried on in Walker County, Alabama. Each person, firm, company, association, agency, corporation or other legal entity engaged therein shall obtain and pay for a license in the sums as set forth in the schedule of license fees.

General Information Regarding Walker County Business License

**Due Date:** All Walker County business license fees are due on October 1st of the current year and will be considered delinquent after November 30th of the current year.

**Late Payment Penalties:** Any person failing to obtain and pay for such license by the last day of November will be assessed an additional 15% penalty. In addition, any person failing to obtain and pay for such license by the last day of December will be assessed additional 5% penalty each month until the license is paid in full.

**Issurance Fee:** In addition to license and fees levied, each person obtaining a license is required to pay the county a fee of five dollars (\$5.00) for every section number listed.

**Sworn Statement Required:** In all cases where the amount to be paid for a license depends on the amount of gross receipts, it shall be the duty of the person applying for such license to render to the County a sworn statement of such gross receipts. Any person subject to such license failing to render the sworn statement required shall be guilty of a misdemeanor and upon conviction, shall be fined a sum of not more than one hundred dollars (\$100.00) and each day's failure shall constitute a separate offense and shall be punishable as such.
