Without opposition, the Chairman declared the motion carried.

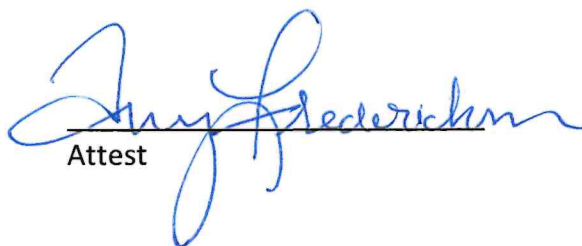
Motion was made by Commissioner Borden and seconded by Commissioner Dunagan that this meeting be adjourned to reconvene at the next regularly scheduled meeting.
