

**April 11, 2025**

At an Emergency Meeting of the Walker County Commission held in their offices in the Walker County Courthouse Annex, Jasper, Alabama, at 9:00 a.m. on the 11<sup>th</sup> day of April 2025, Chairman Miller gave the welcome and called the meeting to order.

County Administrator Amy Frederickson called the roll and Commissioners present were John Dunagan (“District One”), Jeff Burrough (“District Two”), and Jim Borden (“District Three”).

**CONSENT AGENDA:**

Motion was made by Commissioner Borden and seconded by Commissioner Dunagan to Approve the Agenda.

It was also recognized at this time by Chairman Miller that all expected start dates listed in the agenda items were subject to and conditional upon each individual’s successful completion of the Walker County Civil Service Board drug-test and hiring paperwork.

Motion was made by Commissioner Dunagan, and seconded by Commissioner Borden, to open for discussion and approval Agenda Items #1-3 as previously specified.

Without discussion, motion was made by Commissioner Dunagan and seconded by Commissioner Borden to close and vote for the approval of Agenda Items #1-3 with all hiring made conditional upon each individual’s successful completion of the Walker County Civil Service Board drug-test and hiring paperwork.

**ADJOURN:**


