County Administrator, Amy Frederickson, called the roll and the Commissioners present were Commissioner Jeff Burrough, and Jim Borden, and Chairman of the Commission, Steve Miller. A quorum was determined to be present.

CONSENT AGENDA:

ADJOURN:


